I pen down this note with a feeling of pride and immense gratitude reflecting on another year of success for the team at Harman Foundation. Success not just in the conventional terms, but success in seeing women and children rebuild their lives at the HER House, our senior community feeling empowered and cared for through the Care Buddies program, and numerous families accessing food and other essential services through our multicultural service point – the HOPE Hub.

Our collective efforts have resulted in real outcomes for people including 15 women and 5 children provided safe accommodation, 3500+ crisis calls handled, 500 families supported, and much more. We have highlighted key results under each project in the report.

Furthermore, it is with great honour we report that since inception in 2013, our relentless work has resulted in a total contribution of \$9.87 million, comprising \$1.62 million in expenses and the equivalent of \$8.25 million in human hours to the Australian economy. This reflects our commitment to maximising our resources and expanding our impact to create hope in the multicultural communities.

Additionally, last year was a remarkable year for our CEO & Co-Founder, Harinder Kaur, who was recognised with two distinguished honours for her impressive work and passion to help women, children and families. She was awarded the Medal of the Order of Australia and the Australian Sikh Woman of the Year.

An update on diversifying our programs, one of our latest projects the Thrift Factory, which is a pop store for pre-loved evening wear and fashion items, is gaining popularity. The funds raised through the sales are directed towards delivering and expanding our Women Empowerment Workshop which provides seven subject matter expert coaching on key topics including finances, visa paperwork, vocational and career pathways, and more, to women rebuilding their lives.

The impact we make wouldn't be possible without our donors, sponsors, volunteers, and supporters. Their contribution and long-term commitment enable us to deliver these much-needed services to our communities. Our team is deeply grateful for your generous giving, be it donations, skills or time. All this combined results in change making to make our communities safer, stronger and more resilient.

Special Thanks: I express sincere appreciation to our major stakeholders and donors, including the Perera Foundation, IMG Bank Community Foundation, Workers Blacktown, Saaya Touching Lives, Sachdev Foundation, AIMGA, and our esteemed business sponsors and private donors. Message From The CEO


On behalf of the Board of Directors, I am honoured to present the Harman Foundation's (HF) Annual Impact Report along with the Financial Report for the fiscal year ending in June 2024.

We are proud to share that FY24 has been a strong year for us both financially and progressing our projects. In FY24, our total trading income was \$359,240.78 and our total operating expenses were \$270,490.72, giving us

a surplus of \$88,930.06. Considering we had reported a net loss of \$39,074.12 for 2023 fiscal year, it was incredibly vital for us to have a stronger financial base in 2024. The HF team is eternally grateful to our sponsors who have continued to believe in our mission and support us through tough times.

HF encountered specific challenges during COVID including a spike in enquires and limitations of resources. Post-COVID the challenges transformed to re-establishing community services and transitioning programs back to in-person models. Now we find ourselves in an environment of global polycrisis, including steep cost of living, low economic confidence, and widening social gaps, exacerbated by geopolitical tensions and climate change. The multicultural communities' needs are evolving and require more attention than before especially since the largest increase in Australia's population in the last ten years is immigration from India as highlighted by the Australian Bureau of Statistics.





In addition to the issues highlighted above, some persistent challenges that organisations such are ours face include lack of institutional funding, gaps in current infrastructure and systems to grow our presence to meet existing needs, heavy dependence on volunteers resulting in higher attrition and hence, more need to retrain and retain knowledge, and lastly, a shortage of professional skill set at the strategic level to expand our thought leadership.

Despite the challenges our team tackles continually, we run our operations with utmost professionalism and are committed to delivering the highest quality of services to our clients. All our team members and dedicated volunteers are values driven and work with the purpose to find individualised solutions. Every dollar goes into giving the best service possible to every client that comes into our system.

Our 200+ volunteers are the backbone of our operations for the past 12 years. Their commitment and resilience have enabled us to continue making a significant impact on the community, setting us apart from others in the sector.

The HOPE Hub and the Thrift Factory, two of our latest initiatives have done well in the last year. Both projects have expanded their impact footprint, and the senior leadership has taken the decision to further invest in the Thrift Factory to drive sustainable operations. We are able to generate enough funds to host some empowerment workshops. By furthering this revenue stream, we believe we can expand our empowerment sessions to a lot more women in the community.

Some other areas that still remain high priority for the Board and will continue to be our focus in FY25 include strengthening the leadership, further streamlining services and improving alignment with governmental policies and focus areas, building our presence and marketing, and working strategically to secure more government funding.

The HF team is well placed to deliver services needed by the South Asian multicultural communities of Australia, specifically NSW. We have the sector specific knowledge, on the ground experience, well-trained volunteers, well established projects, and most importantly, the passion to make it better – to keep creating hope and empowering lives. With the right financial support, we can expand our presence and grow our capacity to support more women and children seeking refuge, seniors wanting companionship and engagement, and families looking for support.

The HER House, our 24/7 helpline, and the HOPE Hub are our flagship projects that are in need of a funding boost to operate effectively. We will continue to focus on these projects and keep working towards redirecting more funds in these projects. The HF team is cognisant of building operations that have capacity to self-sustain and we will continue to work on this in the coming years.

In conclusion, we are confident to build a stronger system and operations even in these challenging times. We are immensely grateful to each individual, government entity and businesses that have supported us. Above all, we are deeply indebted to the amazing work, empathy and sincerity practised by all our remarkable volunteers and academic partners. We thank you all for your being a part of Harman Foundation. Finally, to all our clients, we promise to keep trying to build a better world – to garner connection, to create hope, and to empower, so you can live your life to the fullest.

Harman Foundation team is heartbroken to share the news of Surpreet Singh's passing. An unfortunate tragedy on 23 November 2024, took his beautiful soul away from us forever. Our deepest condolences to his family, friends and the community mourning this incredible

loss. For the Harman Foundation team, his loss has left a void that no one else can fill.

Surpreet was an integral part of our team and operations. He joined the Harman Foundation team in 2015 and very quickly earned the title of the most reliable team member. His warm smile, can-do approach, and sincere work ethic made him the crowd favourite. He was the person everyone liked going to get help or find solutions, and he would always offer his time and attention so generously.

As our Technology Lead, he was entrusted with the responsibility of setting up our complete technological infrastructure, including setting up the 24*7 domestic violence helpline that serves countless people each and every day. Surpreet not only delivered but went above and beyond to build and improve functionality of our tech system, so we can offer better services to our clients. Thanks to his contribution, our services continue to flourish.









A man who wore many hats – Surpreet took on many roles at both operational and our events. On top of his technology duties, he developed multiple training modules for our volunteers and new joiners to understand and utilise our systems, he was also a project manager for tech adjacent work and managed external consultants, project timelines and budgets, and we can't imagine naming the variety of hands-on tasks he took on at our events. One of our most active participants, he was present at almost every event we hosted. At the annual fundraiser, Surpreet was the most calming influences. Hence, it's not a surprise how efficiently he managed the backstage, which is a complex environment with multiple elements to be managed – and he did it flawlessly. His uplifting presence will continued to be missed at all our future events.

A remarkable human being overall. His personal journey is an example to all of us. At a young age he lost his father, being the elder son and elder brother, he took on the role to support his family financially and contributing to the day-to-day duties of the household. Surpreet devoted himself to the wellbeing of his mother and younger brother. He was resilient, positive and had the ability to make everyone feel special. Members of the community fondly remember their interactions with him and how he left each one feeling lighter and brighter.

The Harman Foundation team is eternally grateful for Surpreet's contribution. We are thankful for his selfless service for the Foundation and his care and dedication in every task he took on. The tech systems he created for the organisation will continue to benefit many clients in the years to come and make us feel his presence. As a gesture of our love for Surpreet, and to honour his hard work for the Foundation, we are announcing an Information Technology award for a student who has demonstrated exceptional achievement in the field studying at the Homebush Boys High School,

where Surpreet Singh studied. Valued at \$500, this award will support the student winner to buy gadgets or equipment to help build their resources. Through this initiative we want to keep Surpreet's legacy going.

Surpreet was a true Harman Foundation's mission champion - he embodied the value of families supporting families. We hope we are able to carry his light and share it with all who come in contact with the Foundation. And each day as we, the leadership team, case manager, and hundreds of volunteers, log into his system, will have his hand in the impact we continue to make.










Donations Given Out

Ten thousand of food hampers, clothing, and essential supplies were distributed. The Harman Foundation is committed to giving back to the community, ensuring individuals and families receive essential support in times of crisis.

Impact (2023-2024):

Over the past year, the Harman Foundation supported 30 families facing crisis due to the loss of a loved one. We helped raise a total of \$115,000, which was donated directly into the families' own bank accounts—not through the Foundation's account. In addition to coordinating community fundraising efforts, we assisted with funeral arrangements and offered emotional support during their time of grief. This compassionate outreach reflects our mission to stand beside those in need and ensure no family feels alone during life's most difficult moments.

It is noteworthy that a generous \$17,517 was contributed in cash donations, while in-kind donations were valued at over \$250,000 during the financial year. These contributions have been instrumental in sustaining our mission and expanding our community initiatives.

Through these initiatives, Harman Foundation continues to foster resilience, empowerment, and dignity, ensuring individuals and families receive the support and resources they need to rebuild their lives.


